launched Agentic AI to improve post-discharge support and reduce readmissions. In August 2026, UHS completed the acquisition of Talkspace, which utilizes a technology-enabled, HIPAA compliant virtual platform and its AI-powered mental health guide, Tee. Looking ahead, UHS will continue to leverage AI and advanced technologies aimed to support patients and enhance quality and operational efficiency, all while preserving the human touch that defines our care.

Behavioral Health Division (inpatient, partial hospitalization, outpatient, residential and telehealth treatment programs)

The division continues to achieve positive and recognition for quality care:

- UHS BH Medicare hospitals participate in CMS' Inpatient Psychiatric Facility Quality Reporting Program (IPFQR) used by approximately 1,450 psychiatric providers across the U.S. to measure a broad set of evidence-based clinical practices linked to positive patient outcomes and are published on CMS' Hospital Compare web site. **UHS BH hospitals' aggregated results regularly exceed national averages for key metrics.**
- We collected more than 400,000 patient satisfaction surveys in 2025. On a five-point scale (1 being low and 5 being high), **UHS patients rated their overall satisfaction during this period at 4.4⁵.**
- According to the 2025 patient satisfaction surveys, 90% reported feeling better after care, while 89% reported that they were treated with dignity and respect. Additionally, 89% report that their treatment goals and needs were met³.

- We measure loyalty using the question, “How likely would you be to recommend this facility to a friend or family member?” In 2025, the UHS Behavioral Health Division’s Net Promoter Score was 45, which represents the percentage of promoters minus the percentage of detractors. This score is considered great by industry standards³.
